

KNX SCALE OF FEES FOR PRODUCT QUALIFICATION AND CERTIFICATION¹

1. Basic Fee

	C	€ 16	For the registration of any additional products in an existing derived product group
	D	€ 16	<ul style="list-style-type: none"> ▪ Recombination of an already registered product with an already registered application and vice versa ▪ Attribution of an already registered application to a new product
	E	€ 16	For each combination of a hardware-software <u>already</u> registered/certified according to a legacy standard, if former certification covers all relevant requirements of KNX standard. If not, see cases A to D
Adaptation of version of bus coupling unit	-	€ 180	<ul style="list-style-type: none"> ▪ For the registration of any hardware which had previously been registered for another medium [e.g. TP1 device update to PL132] ▪ For the registration of any hardware which had previously been registered with another mask version type [e.g. update of product from BCU1 to BCU2]

- For initiating the procedure and providing certification support to the applicant
- This fee is payable at the date of registration of the product data in the ETS database (if applicable).

2. Audit fee

Type of Audit	Fees	excluding
Pre-license Inspection: assessment of applicant's Quality Management System according to ISO 9001	€ 1000 per person (minimum two persons, minimum two days)	travel expenses, living allowance and hotel accommodation

- covers expenses for the KNX system audit (= examination and evaluation of the applicant's Quality Management Handbook and relevant documentation), preparation of the audit (submission of an audit plan), executing the KNX implementation audit and a detailed audit report after the implementation audit
- the Pre-License inspection is **not** carried out when the applicant can submit a copy of QMS Certificate of an accredited body together with a copy of its quality manual.

3. Product testing fees

- Consult one of the Accredited test labs (see <https://www.knx.org/knx-en/community/test-labs/list/index.php>)
- For tests, for which no uniform KNX test specifications exist, carried out by the KNX Certification Department via witness testing at the applicant's premise, the following hourly rate is charged **€125** (excluding travel expenses, living allowance and hotel accommodation)

4. Annual Surveillance Fee

€75 per certified main product group

- covers expenses for the surveillance of the certified KNX products (carried out by KNX accredited test labs on KNX' instigation)
- These expenses are charged at the end of each year.

All prices are exempt from Belgian V.A.T. for any company outside Belgium, provided KNX has the applicant's V.A.T. number.
